

RESOLUTION NO. R-14-03

CHARTER TOWNSHIP OF MUNDY

At a regular meeting of the Charter Township of Mundy Board, held on Monday, April 28, 2014, at 7:00 p.m., where a majority of the Township Board was present, the following Resolution was offered by Treasurer Oskey and supported by Supervisor Guigear;

WHEREAS, the Charter Township of Mundy has adopted an Ordinance, being Ordinance 92-W, that requires the Township to adopt, by way of Resolution, certain rates relative to water and sewer usage within the Township; and

WHEREAS, certain usages and the charges and expenses for such usage and services vary from time-to-time; and

WHEREAS, it is necessary for the Township to regulate, control and charge for such services and commodities; and

WHEREAS, certain terms are used within the context of establishing such fees and costs,

WHEREAS, other resolutions have been passed from time to time relating to and regulating such services and commodities,

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF THE CHARTER TOWNSHIP OF MUNDY AS FOLLOWS:

That the following definitions shall apply:

That "**REU**" shall mean residential equivalent units.

That "**RTS**" shall mean ready-to-serve charge.

That "**CCF**" shall mean a hundred cubic feet.

That "**Irrigation meter**" shall mean use for outdoor lawn usage, so as not to be part of the water placed in or directed to the sanitary sewer system.

That "**senior citizen**" shall mean a person who has reached the age of sixty-two (62).

BE IT FURTHER RESOLVED THAT:

The rates and changes contained herein shall be effective July 1, 2014.

BE IT FURTHER RESOLVED THAT:

The **monthly sewer rates** where there **is** metered water usage rates available shall be:

RTS of \$9.36 per **REU**, plus \$1.82 per **CCF**

The **monthly sewer rates** where there is **not** metered water usage rates available shall be:

\$32.12 per **REU**

That all **senior citizens** shall have a ten percent (10%) reduction on the rates for sewer usage.

BE IT FURTHER RESOLVED THAT:

That the monthly **RTS** water charges shall be as follows:

5/8"	\$15.34
3/4"	\$23.01
1"	\$38.35
1 1/2"	\$76.70
2"	\$ 122.72
3"	\$ 230.10
4"	\$ 383.50
6"	\$ 767.00
8"	\$ 1,227.20

Plus the usage fees of \$3.94 per **CCF**.

BE IT FURTHER RESOLVED THAT:

The monthly water rates where there is metered water usage for **irrigation** purposes shall be billed at fifty percent (50%) of the **RTS** charge throughout the entire year.

<u>Meter Size</u>	<u>Amount</u>
5/8"	\$15.34
3/4" and larger	\$23.01

Plus the usage fees of \$3.94 per **CCF**.

BE IT FURTHER RESOLVED THAT:

There shall be a charge for use of water from **fire hydrants**, as such is metered and controlled by Genesee County.

BE IT FURTHER RESOLVED THAT:

The **late payments** shall be subject to a penalty of two percent (2%) of the unpaid portion of each and every bill.

BE IT FURTHER RESOLVED THAT:

All **unpaid fees** and charges shall be added to the tax rolls and become part and parcel of real property taxes against the property.




