

CHARTER TOWNSHIP OF MUNDY

ORDINANCE NO. 92-11-A

AN ORDINANCE TO AMEND PRIOR ORDINANCES OF THE TOWNSHIP TO RELATE TO THE LATE CHARGES ON WATER AND SEWER BILLS, TO ADDRESS THE CONNECTION FEES, AFTER NON-PAYMENT OF A BILL AND TO ADJUST AND AMEND THE DEFERRAL PAYMENTS ON WATER CONNECTION FEES TO A PUBLIC WATER SYSTEM, ALL FOR THE HEALTH, SAFETY AND WELFARE OF THE RESIDENTS OF MUNDY TOWNSHIP AND TO PROVIDE FOR THEIR WELLBEING AND SAFETY.

THE CHARTER TOWNSHIP OF MUNDY HEREBY ORDAINS:

SECTION I

UNTIMELY PAYMENTS

A. Any water or sewer charges not timely paid by the due date as noted on a bill for such service shall be subject to a penalty as established by the Township Board, by virtue of a resolution, and as amended from time-to-time.

B. That any such water or sewer usage charges, if not paid within ninety (90) days of the due date, shall then commence to be charged and draw interest on said charges at a rate as determined by the Township Board, by resolution, and as amended from time-to-time.

C. In the event that the charges for any water or sewer services as furnished to any premises are not be paid within one hundred twenty (120) days after the due date thereof, then all services furnished shall be discontinued.

D. Any service discontinued as noted herein, shall not be restored until all sums due and owing to the premises, including penalties and interest, shall be paid, plus an additional fee of Fifty Dollars (\$50.00), for each such service. The charge is for the restoration of such services.

SECTION II

CONNECTION FEES

The owner of premises where municipal water or public sanitary sewer is being connected may elect to pay a connection fee on time payments by paying fifteen percent (15%) of the total computed Township connection fee when the connection permit is issued, and the balance to be paid as set forth by resolution, by the Township Board, and as amended from time-to-time. Such resolution shall set forth all terms and conditions specifically including the time for payments and the interest rate to be charged.

SECTION III

REAFFIRMATION

All parts of any other Ordinance not specifically amended hereby are reaffirmed, as if fully set forth herein, including all prior water and sewer ordinances, and parts thereof.

SECTION IV

SEVERABILITY


